Remember, filing an extension, only relieves you of the failure to file penalty, but it does not relieve you of the late penalty for not paying your taxes. 2003 Extension Forms

Individuals

- 1. 1040 Filers due 4/15/2004 Form 4868 which gives you a four month extension, will be due August 16, 2004.
- 2. 1040 Filers due 8/16/2004 Form 2688, which allows you an additional two months, but it is not automatic and only allowed for undue hardship.

Partnerships

- 1. 1065 due 4/15/2004 Form 8736, which allows you an additional ninety days.
- 2. 1065 due 7/15/2004 Form 8800, which allows you an additional ninety days.

Corporations

1. 1120/1120S due 3/15/2004 - Form 7004, for a 6 month extension, which makes the return due on September 15, 2004.

Estate Tax Returns

- 1. 706 for Estate Tax Returns due Form 2758 for ninety days.
- 2. 1041 for Estates due April 15, 2004:
 - · Estates file Form 2758 for an extension, plus another Form 2758 for an additional 90 days.
 - · Trusts file Form 8736 for a ninety day extension, plus Form 8800 for an additional 90 days.

Non Profit

1. May 17, 2004 Form 8868 for 90 days

1. July 15, 2004 Form 5558 for a 75 day extension.
