Optional State Sales Tax: What is it?

The Internal Revenue Service recently made available what has been named the Optional State Sales Tax Table to taxpayers.

The American Jobs Creation Act of 2004 authorized the sales tax deduction as an option for those who itemize deductions, letting them choose between deductions for state and local income or sales taxes.

In Texas and seven other states, residents don't have to choose with tax break helps more because they pay only sales tax but they do have to itemize to use the sales deduction.

The tables show set deductions for individuals in each state based on income and the number of people claimed on the tax return.

Taxpayers who have bought or will buy big-ticket items such as cars, trucks and boats can combine the standard deduction estimate with the actual amount of sales tax paid on those items.

The IRS has also said that taxpayers who bought or will buy airplanes and other aircrafts; traditional, mobile and manufactured homes; and home building materials to construct, repair or remodel homes also have the potential of writing off the sales tax on those items.

Helpful Holiday Hints

With the festive season upon us, many of us forget that some of our gift giving and charitable donations can also provide us with some tax deductions. Here are a few to help you through the holidays.

- Gifts to customers and clients are deductible, however only to the limit of \$25 per person per year. The cost of sending holiday cards can also be deductible, for both the cost of the card and the postage. If you are self-employed the deductions come straight off your gross income, however if you are an employee these items are deductible as a miscellaneous itemized deduction.
- Whether you receive a turkey, chocolates or other holiday tokens from your boss, they are classified as gifts. They're not taxable, so you don't need to worry about claiming them on your income tax return. However, instead of received a \$40 gift hamper you receive \$40 in cash, you must claim it as income.
- If you buy a Christmas tree from a non-profit organization such as a church there is a deductible. If you pay \$80 for a 5-foot pine tree, and 5-foot pines are available for \$50 all around town, then the \$30 difference is a deductible. It's considered your donation to the organization. The same goes for other items such as Hanukkah menorah or Kwanzaa candles.

Strange But True

Following on from the previous issue we have included some more strange taxes. In this issue we look at two that involve food and beverages plus one for playing cards:

Takeout Tax

Would you like fries and a tax with that? The City of Chicago has levied a 0.5 percent charge on all carryout food, technically called the "anti-litter" tax. This applies to everything from a Happy Meal to a hot dog sold from a street vendor. So when you are buying your take out just remember that you are paying an extra bit to the city. Washington D.C has the takeout tax as well.

Fountain Soda Drink Tax

This strange tax also comes from Chicago. When you purchase a "fountain soda" drink such as a Coke or a Pepsi you will pay a flat rate of 9 percent to the city of Chicago. If you purchase a soda that is in a can or a bottle, then you are free from the tax, it only applies to the cups of drink, "the fountain soda."

Playing Card Tax

If you are in the state of Alabama and want to purchase a deck of cards, be prepared to shell out an extra dime. The state government has levied a 10-cent tax on the purchase of a playing deck that contains no more than 54 cards. If you object to this, get your playing cards in a different state or buy a deck with an extra joker.

News From The IRS Bringing Back Ethics Into Tax

As part of its ongoing effort to improve the ethical standards of tax professionals and to curb abusive tax avoidance transactions, the Internal Revenue Service recently issued amendments to the Treasury Department Circular 230.

Circular 230 is applicable to attorneys, accountants and other tax professionals who practice before the IRS. The revisions to Circular 230 is to provide standards of practice for written advice that reflect the current best practices and are intended to restore public confidence in tax professionals.

Following on from the recent discovery of some tax professionals and attorneys providing opportunities for clients to illegally rort the tax system the IRS believe that these amended regulations will send a strong message to any person considering selling questionable advice to clients.

Ensuring that attorneys, accountants and other tax practitioners adhere to professional standards and follow the law is on the IRS' top enforcement goals at present.

The final regulations provide the best practices for all tax professionals including mandatory requirements for written advice as well as minimum standards for other advice, with serious penalties there is a failure to adhere to the guidelines.
